A penalty fee will be applied if they arrive too late or leave too early.

**CLASSIFICATION**

If any **Male Category A athletes**, do not upload MDF, Athlete Consent Form, and the supporting medical documentation onto the World Abilitysport - Sports Management System (WA-SMS) by **9 JANUARY 2025**, for Athlete Reassessment, they will be ineligible to compete at the World Cup.

If any **Male Category A athlete** was reassessed in Pisa, Italy in November 2024, they do not need to be seen again and are eligible to compete.

We encourage all Nations to upload all **Female Category A athlete's** MDF, Athlete Consent Form, and the supporting medical documentation onto the World Abilitysport - Sports Management System (WA-SMS), as some Female Category A athletes will be seen in Sao Paulo, Brazil at this 2025 Wheelchair Fencing World Cup."

The data from the entry form and Ophardt system must be consistent and current. It is responsibility of national federations to inform World Abilitysport and LOC about any changes and keep all data up-to-date.

#### **ACCREDITATION PAYMENT**

Accreditation fees must be paid directly to the LOC office at the venue before the competition, by credit card or cash, or along with the accommodation invoices, if requested by the delegation.

#### **INSURANCE**

All members of attending delegations should insure themselves in case of accidents, injuries or illness. The organizer will not accept any responsibility or financial loss or any other responsibility incurred by any of the participants whatsoever.

#### **DELEGATION MEETING**

Will be held in the Paralympic Center.

#### **IMPORTANT NOTE**

In Brazil, moral and sexual harassment, prejudice and discrimination based on religion, race, gender or sexual orientation is a crime.

Any situation that occurs in the competition will be reported to the police authorities.

The **World Abilitysport Registration Fee** (50 GBP per person), a possible **Late Entry Surcharge** (150 GBP per person after the entry deadline and until 3 days before the competition, 250 GBP until the head of delegation meeting), the **fine for missing referees** (1.500 GBP per missing referee before and 2.000 GBP after the entry deadline) and possible other fines must be paid directly to World Para Fencing.

Please note that all fees and penalties payable to World Para Fencing will be invoiced **AFTER THE COMPETITION**.

#### **START TIMES**

The start times of individual and team events may be subject to change to another time on the same day after the final entry deadline, when the entry numbers of athletes and teams are known.
