DEADLINE: 3 NOVEMBER 2022

The data from Ophardt system and the entry form must be consistent and current. It is responsibility of national federations to inform LOC AND IWAS about any changes and keep all data up-to-date.

In exceptional situations:

- the registration of accommodation packages with the organizers after 3rd November 2022

- the registration of athletes and officials in Ophardt system after 9th November 2022

may be considered by LOC AND IWAS and may be accepted, but 20% penalty fee will be added by the local organizers to the regular fee and the late entry surcharge by IWAS (see rulebook o.56.4).

CANCELLATION POLICY

Any cancellation of ordered accommodation packages after 4th of November but before 14th of November will result in applying the cancellation fee:

50% of packages that have been ordered and cancelled.

Any cancellation of ordered accommodation packages after 14th of November will result in applying the cancellation fee:

100% of package that have been ordered and cancelled.

Please note: After the closing deadline for entries, there can be no further withdrawal of a name except in any case of force majeure duly justified (see rulebook o.56.3).

PAYMENTS FOR ACCREDITATION AND ROOM RATES

Accreditation Rate and Room Rates must be paid directly to the local organizers.

The accreditation rate will allow competition accreditation only.

Airport transfers, travel to venue, accommodation and food is not included.

The room rates will include accommodation and food in the official hotels, airport transfers to the

hotels and between the hotels and the venue.

Day rates start from the dinner on the day of arrival and continues until breakfast on the day of departure.

At the nation's request, the invoice may be issued in EUR based on the exchange rate of the National Bank of Poland on the date of issue of the invoice.

INSURANCE

All members of attending delegations should insure themselves in case of accidents, injuries or illness. The organizer will not accept any responsibility or financial loss or any other responsibility incurred by any of the participants whatsoever.

IMPORTANT NOTE

The **World Abilitysport Registration Fee** (50 GBP per person), a possible **Late Entry Surcharge** (150 GBP per person after the entry deadline and until 3 days before the competition, 250 GBP until the head of delegation meeting), the **fine for missing referees** (1.500 GBP per missing referee before and 2.000 GBP after the entry deadline) and possible other fines must be paid directly to World Abilitysport WF.

Please note that all fees and penalties payable to WF will be invoiced **AFTER THE COMPETITION**.
