The minimum of four fencers from three World AbilitySport countries for Zonal competitions outside of Europe. A fencer without an official international classification is not allowed to participate in an World Para Fencing competition. The placing of competitors within each category is strictly according to the decision of the official classifiers authorities who have examined and classified each competitor before the competition.</p>

A penalty fee will be applied if they arrive too late or leave too early.</p>

The **World Abilitysport Registration Fee** (50 GBP per person), a possible **Late Entry Surcharge** (150 GBP per person after the entry deadline and until 3 days before the competition, 250 GBP until the head of delegation meeting), the **fine for missing referees** (1.500 GBP per missing referee before and 2.000 GBP after the entry deadline) and possible other fines must be paid directly to World Para Fencing.
